TECHNICAL COLLABORATION AGREEMENT

This Technical Collaboration Agreement (hereinafter referred to as "TCA") is made and entered into on this 19th day of February, 2025, BY AND BETWEEN:

Shriram Institute for Industrial Research (SRIFIR), a unit of Shriram Scientific and Industrial Research Foundation having its office at Plot No 76 D & E, Near HIPA, Sector 18, Gurugram, Haryana – 122015 India (hereinafter referred to as "SRIFIR"), which expression shall, where the context so admits, include its successors and assigns;

AND

Easy Raw Materials Private Limited, a company registered under the companies Act 2013, dealing in manufacturing of nutraceuticals products, having its registered office at Office No. 403/404, 4th Floor, K.L. Accolade, 6th Road, TPS III, Santacruz(East), Mumbai, Mumbai, Maharashtra, India, 400055 and proposed manufacturing site at Plot No. F1, Sector 7 admeasuring 4,120 Sq.Mt. (44,347 Sq. Ft.) in the SEZ area situated at JN Port Navi Mumbai, Maharashtra, hereinafter referred to as "EZRM", which expression shall, where the context so admits, include its successors and assigns.

"SRIFIR" and "EZRM", are individually referred to as a "Party" and collectively referred to as the "Parties."

WHEREAS:

A. SRIFIR was established to conduct research activities in various scientific and industrial fields and to promote and encourage scientific research, especially in relation to manufacturing, commerce and industry. It also possess expertise and knowledge in the field of nutraceutical sector.

B. EZRM is engaged in the business of carrying on the business of buying, selling, reselling, importing, exporting, transporting, storing, developing, promoting, marketing or supplying, trading, dealing in any manner whatsoever in all type of goods on retail as well as on wholesale basis, e-commerce platform for buying and selling raw materials in India or elsewhere.

C. The Parties seek to establish a collaborative relationship for research, formulation, development and innovation in the nutraceutical products through the said agreement.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the Parties agree as follows:

1. PURPOSE

The purpose of this Agreement is to establish a collaboration between SRIFIR and EZRM for the development, production and formulation of a new nutraceutical's product, utilizing SRIFIR's Technical Know-How and EZRM's expertise in the field of nutraceuticals formulation, manufacturing, and regulatory affairs.

2. CONSIDERATION

The parties further agree that the consideration under this Agreement will be based on the actual utilisation of the exchanged information, resources, and expertise, with the value of such consideration determined by the extent and scope of their usage in accordance with the terms set forth herein.

3. SCOPE AND AREAS OF COLLABORATION

3.1 Research Collaboration: The Parties will collaborate on mutually agreed research projects in the nutraceuticals industry. Both Parties shall utilize their expertise, facilities, and resources to advance shared research goals on mutually agreed financial terms.

3.2 Formulation Development: SRIFIR shall provide technical expertise and support in the development of innovative nutraceutical formulations, including research and optimization of ingredients, stability studies, and efficacy testing.

3.3 Product Testing: SRIFIR and EZRM shall jointly conduct testing and clinical trials to validate the efficacy and safety of the nutraceutical's product.

3.4 Internships and Training: SRIFIR may provide internships to students or researchers from EZRM to offer practical, hands-on experience in nutraceutical research and development. Similarly, SRIFIR scientists may engage in workshops or specialized courses organized by EZRM.

3.5 Collaborative Projects: The Parties may apply jointly for national and international research grants and funding opportunities related to the nutraceuticals industry.

3.6 Workshops and Seminars: Both Parties may organize joint workshops, seminars, and conferences on areas of mutual interest in the nutraceutical's domain.

3.7 Intellectual Property Rights: Ownership of any intellectual property developed during the collaboration will be decided on a case-by-case basis as per mutual agreement between the Parties.

4. UNDERSTANDING OF PARTIES

3.1 This TCA is non-binding and does not create any financial obligation on either Party unless otherwise specifically agreed upon in writing.

3.2 Future collaborations will be governed by separate definitive agreements that will outline the specific terms and conditions for each joint activity.

5. TERM AND RENEWAL

This TCA shall remain in effect for a period of 24 months, commencing from the date of signing. The TCA may be renewed or extended by mutual agreement between the Parties.

6. CONFIDENTIALITY

Both Parties agree to maintain the confidentiality of any information identified as confidential during the term of this TCA. No Party shall disclose any confidential information to third parties without the prior written consent of the other Party.

7. TERMINATION

Either Party may terminate this TCA by providing ninety (90) days' written notice to the other Party. The termination of this TCA will not affect any ongoing projects or obligations entered into before the date of termination.

8. INTELLECTUAL PROPERTY

The ownership and use of any intellectual property generated as a result of the collaboration will be determined by separate agreements specific to the project or collaboration.

This TCA may be amended or modified only by a written agreement signed by both Parties.


11. FORCE MAJEURE

Neither Party shall be liable for failure to perform its obligations under this TCA if such failure is due to events beyond its reasonable control, including but not limited to acts of God, war, strikes, or government regulations.
